**Introduction:**

GRC Wireless Inc. (GRC) has been at this location since 2007, employs 25 people, and is on public utilities. GRC occupies 15,000 square feet at this facility. GRC has never notified as a hazardous waste handler, however this inspection was the result of a request from Tallahassee.

**Process Description:**

GRC's business is purchasing used cell phones and reselling them on the worldwide market, or recycling the components for repair parts. Phones are purchased from businesses or from non-profit organizations who collect phones from individuals and sell them to GRC as a fund raising program. Phones that cannot be resold or their components are not usable, are shredded and smelted down to recover the metal. This process takes place in at Umicore Precious Metals Refining in Hoboken, Belgium where approximately 100,000 pounds of GRC's used phones are processed each year. Umicore purchases the recovered metals from GRC.

Batteries that are no longer useful for their intended purpose are sold to Cellrunners in Pompano Beach Florida.
